Bond/compensation payment agreement

To finalise VCAT bond (and compensation) claims without a hearing

You can use this form where a person has applied to VCAT under the *Residential Tenancies Act 1997* for **payment from the BOND** held with the **Residential Tenancies Bond Authority** and you have reached an agreement on how the bond monies should be paid, **and (where relevant) any additional orders for compensation (if the claim includes additional compensation)**.

On receiving this **Bond Payment Agreement**, VCAT will recognise it by making orders **without** holding a hearing. We encourage parties to lodge this agreement **as early as possible**.

If a hearing has been scheduled, VCAT will cancel the hearing, provided this document is lodged at least **three business days before the hearing date**. If you reach an agreement after that date, the hearing will most likely proceed and this agreement can be presented at the hearing.

All renters with an interest in the bond MUST sign this agreement for it to be given effect.

NOTE: If the bond was paid by Homes Victoria (formerly DFFH / DOH), the Tribunal will **only** accept the **Bond Payment Agreement**, if the renter/s sign the acknowledgment relating to the payment to Homes Victoria.
